Parent and Child Information Check List

- Registration** Fill out permission slip, child info sheet, and name/date sheet. All items provided are at no charge; the only item retained by the Nebraska Freemasons is the permission slip.
- Webcam Photo** A webcam still photograph is recorded on CD for use in the Amber Alert system or, if needed, by the proper authorities. Only the parent or guardian receives the CD. No photos are retained by the Freemasons or any sponsoring entity.
- Webcam Interview** An interview will be recorded on CD, providing a front, left and right profile, and back view. Questions asked are generalized to get insight on the child's voice, speech, favorite items and places, and mannerisms that may be helpful if the need arises.
- Fingerprint** The child's prints are recorded by scanner and printed on the page with photo and child info. The information page, including the prints, is also downloaded to the CD. Note—The information entered into and gathered on the computer system will be deleted after burning to the CD. Parents may witness the erasure process.
- Toothprint™** A dental or medical professional will take an imprint of the child's teeth by placing a warm specially formulated dental material in the child's mouth. Biting down firmly causes the material to hold the bite pattern in the material and also provides a DNA sample that will last several years when kept sealed in the bag provided. **Do not touch the wafer with bare hands!** Keep the Toothprint™ wafer in a safe place with the other CHIP items.
- Cheek Swab** A dental or medical professional will take a DNA sample by swabbing the inside of the child's cheek. This DNA sample will be useful for over 20 years when kept in a home freezer.
- Check Out** Please visit the check out station to complete the CHIP kit process.

This service is provided at no-charge by the Nebraska Freemasons. In the event of a problem, the authorities will have the necessary information available to them. The Nebraska Freemasons do not retain any information about the child except the permission slip
